The 2011 Scappoose Farmers' Market, sponsored by the Scappoose Community Club, is primarily an agricultural market encouraging purchases of locally grown plants and produce. Written approval is required for the sales of local, handmade crafts, and locally made artisan foods such as herb vinegars, preserves, and salsas. The vendor also agrees to indemnify and hold harmless the Scappoose Community Club (the Club), the officers, employees, and agents of the Scappoose Community Club, City of Scappoose, owners of Lorelei Village, and or other leaser/owners of the properties where the 2011 Scappoose Farmers' Market is located, from any and all claims, actions, judgments, losses, cost (including reasonable attorney fees), and damages whatsoever including claims arising by reason of accident, injury or death caused to persons or property of any kind, arising out of, in connection with, or incident to, the 2011 Scappoose Farmers' Market and/or location. **Vendors are strongly encouraged to obtain general liability insurance** and list the Scappoose Community Club Farmers' Market as an additional insured. Scappoose Community Club Farmers' Market is not responsible for any loss or damage incurred by vendors.

Should a vendor at any time occupy the premises in a matter *that fails to comply with the rules of the Market, or in any manner that is hazardous or offensive to the public*, the Club, the Owner, or other vendors, upon request of the Club or its representative(s), vendor shall immediately cease such offending conduct. Failure to immediately conform its conduct as requested shall be cause to revoke this agreement and the vendor permit. Upon failure to so vacate, the Market is authorized to remove all property of vendor from the premises at the vendor's expense. The Club and Owner will not be responsible for storage or safekeeping of property so removed.

I understand that I am to notify the Club, or Market Manager, in writing, if I do not wish to have my phone number given to callers making inquiries to the Market.

Length of Reservation: Preferred spaces will be assigned for the full season to Full Season Vendors only. Market will attempt to accommodate vendors requesting multiple dates for assigned spaces accordingly. Weekly vendors will be assigned on a first call, first served basis.

Full Season Reserve Vendor (May 21 – October 1). A check for full payment in advance must be included with application. A pro-rated refund will be issued for an unused space if Vendor notifies the Market Manager by Wednesday night of the week immediately prior to market day that the reserve spaced will not be used.

[] **Weekly Call-in Vendors.** Vendor should call Market Manager by Thursday night, on a weekly basis, and request space for Saturday, however, qualified vendors may be accepted morning of the market day *if space is available*, and will be assigned to booth space *as available* by Market Manager or his/her assistant. Payment for space fee is due, in cash (or approved check), by 8:30 a.m., morning of the market, or as otherwise collected by the Market Manager. **Hours of operation: 9 a.m. to 2 p.m., unless otherwise notified by the Market Manager.**

Space assignments: Products may be sold from canopies/tables or a combination of a table and a pickup truck bed, concession trailer, if space is available. Vendor: please specify number and size of spaces.
